There is one optional exeat weekend per half term. (see <u>Term Dates</u>) Boarders may stay in school if they wish at a cost of £150 plus VAT (£180 incl VAT).

There will be activities running as normal at an additional cost in line with the usual weekend boarding costs of up to £75 each weekend. Most of these charges will also be subject to VAT.

All tuition, boarding and school transport fees are payable in full in advance and any changes are subject to one term's written notice to be received by the first day of the proceeding term. The cost of external exams e.g. GCSEs are also chargeable in advance. Fees must be paid on or before the first

day of the term to which they relate. Disbursements for Additional Specified Charges are normally invoiced as extras, in arrears, together with the advance fees. Should there be a need for the School to chase for late payment, administration and additional costs will be charged.

Insurance for the loss, theft, or damage to a pupil's personal possessions whilst at school remain the parents' responsibility.

Pupils sometimes need to purchase personal materials and their own texts, which they can annotate for examination purposes.

A £1,800 deposit (inclusive of VAT) becomes payable once a place is offered, and this will be set against the final term's disbursements (i.e. at the end of the final term).
